Financial Report 2015-16

The year had been quite encouraging for us as regards the financial position of the Trust. The audited balance sheet is placed in front of you. There are some new items added to Balance sheet special in the following regards.

- a. For the first time we have included the cost of building in the balance sheet. Please see the right hand side of the consolidated balance sheet (Annexure-I). This was An omission deliberately made in our earlier balance sheet since land and building were not transferred to trust in the records of Revenue Dept. till last year.
- b. For the first time we have included donation receive in kind converted to actual cost as told by the donors and in the basis of that, it is reflected in the statement of receipts and payment accounts Annexure-III. Similarly in the expenditure also we have added the value of the consumable donated and used in this financial year.

You may have a doubt about the difference in the donation received in Annexure-II and III . This is because the present value of building is added in income and expense account, but not in Receipts and Payments accounts as per accounting norms.

d. The names of major donors who have donated huge amount in this FY year are appended along with balance sheet. I will read it out for the benefit of all. In this regard I want to bring to the notice of the August gathering that the amount donated by Give India was much more this year because of the personal appeal of Chairman to Give India to grant us a General Fund to build our Corpus. They donated lump sum amount of Rs 5,48,702.00 for General fund alone on the basis of his request. I also like to inform you that Sri. Amar Jyoti Barua son of our Chairman has been donating to us an Amount of 3 lakhs every year from the conception of the trust. We have already received the donation of 3 lakhs for this financial yearfrom him. An amount of Rs. 1 lakhs was donated by Anubhav Kela a resident of Singapore and friend of Amar Jyoti Barua. Last Financial year also he donated similar amount to us. Our Special thanks and appreciations to 5mt. Anjana Barooah and 5mt. Arati Bhattacharje for their lump sum donations of 1 lakhs each. This organisation was established by our kind hearted chairman by his donations only. He was also donating whatever necessary every month run the home. In this financial year also he donated total of Rs. 2,47,400 to the trust in total. We are grateful to him for his greatness. We have also received a considerable amount in cash and in kind from different individuals and organisations which is reflected in the total receipt. The list is huge. It is not possible to take their names individually now but we thank them profusely for their support. Other Salient features of the Financial year are--

- We spent Rs. 1,15,410.00 for storm water drainage and filing the Lawn with green cover resulting in stoppage of accumulated water.
- 2) I am happy to announce that in the year we have added Rs. 9 lakhs to our corpus Fund.
- 3) Annual Day Celebration cost us Rs. 1,95,529.00. We were able to collect Rs.1,77,000.00 towards advertisement on the souvenir published on the occasion. An amount of Rs. 40,000 is due from Govt of Assam. Dr Padma Pani Mahanta is liaisoning with them for release of the amount.

You will be glad to know that Ministry of Home affairs Govt. of India after due diligence authorised us to receive Foreign donations from 26-8-2015. Our doors are now open for all of you to try to get us whatever possible from foreign donors. We hope we will also be able to get some amount through foreign sources in the current year.

Now I like to introduce the budget for the FY 2016-17 for your kind consideration and approval.
